### Notice To Exhibitors & Show Site Rules

Entry fees shall not be refunded in the event that a dog is absent, disqualified, sick, lame, excused by the Judge or Veterinarian, or barred from competition by action of the Show Committee, or because it has been entered incorrectly. There is no refund of entry fee for bitches in season. There is no refund for DUPLICATE ENTRIES. If, because of riots, civil disturbances or other acts beyond the control of the management it is impossible to open, or to complete the Show, No refund of entry fee may be made. Returned checks shall have a collection fee of \$20.00 added to the amount of the check.

No dogs will be allowed in the show area except those regularly entered in the Show.

The judging will start promptly. Dogs may arrive anytime prior to their time of judging and may leave immediately thereafter unless required for further judging. It is the responsibility of the exhibitor to have his dog ready to be shown and at the entrance of the judging ring when the steward calls for the class.

LOSS OR DAMAGE: The Show Committee will use due care and diligence for the welfare of dogs and exhibitors but will not be responsible for or assume any liability in the event of any accident or misfortune to either dogs or exhibitors participating in this Event. The welfare of an exhibitor's child is assumed to be the responsibility of the exhibitor. It is distinctly understood that exhibitors will exercise control and restraint over their children on the day of the Show.

The Show Site will be available to exhibitors at 6:00am, Friday, August 20<sup>th</sup>, 2010.

#### SET UP OF TENTS/EQUIPMENTS MAY NOT BE WITH 15 FEET OF ANY RINGS. THIS WILL BE ENFORCED

Grooming will be in the livestock building located in the northeast corner of the grounds.  
USE OF ALL POWER OUTLETS IS AT USER'S OWN RISK.

LOADING & UNLOADING: There will be NO loading or unloading of crates/dogs at ringside during show hours! Loading and unloading will be in the livestock building only located in the northeast corner of the grounds. Access to the Livestock Building will be off 284<sup>th</sup> Ave SE – follows signs on Friday- gate open at 6:00am  
No vehicles will be allowed on the show grounds after 7:00am on Friday unless they have reserved parking.

PARKING INFORMATION: THERE WILL BE NO DAY PARKING ON THE FAIRGROUNDS

No practicing allowed in rings at any time. No dogs to be left overnight in grooming building. Each exhibitor is responsible for cleaning up after his own dog(s). No skateboards, roller blades, scooter or bikes will be allowed on the show grounds.

### ROUTES TO THE SHOW

FROM THE NORTH OR SOUTH ON I-5 – Take the Auburn Exit (Exit 18). Go to Auburn and take the Enumclaw Exit to Highway 164. Follow the signs to Enumclaw (Highway 410), just before Enumclaw turn right on 244<sup>th</sup>, go to 456<sup>th</sup> and turn left. It becomes Warner. Stay on Warner to the fairgrounds.

GOING SOUTH ON I405 OR COMING FROM THE RENTON AREA – Go east on Maple Valley Highway. (Highway 169) go through Black Diamond, continue on until 416<sup>th</sup> SE, turn left, and then follow signs to the fairgrounds.
